Investment Objective

The Martello Global Equity Fund ("the Fund") aims to achieve long term capital appreciation through investment in listed equities on a global basis.

The fund is primarily intended for investors with a long-term horizon of at least 5 years.


Investment Strategy

The Fund will invest in a diversified portfolio of listed equities. Assets of the Fund are typically limited to, but not confined to, those companies listed on the markets of the UK, Europe and North America.

The investment advisor will apply a rigorous investment selection methodology to select securities for the Fund's investment portfolio. These criteria are designed to ensure that the Fund invests in high quality businesses with proven management competencies and strategy execution.

It is envisaged that the investment portfolio of the Fund will be concentrated, comprising between 20 and 30 stocks. However, the portfolio will be invested with the aim of providing a prudent spread of risk, and there are limits on the concentration of the investments held.


Fund Performance








Global Equity Fund Sector Relative Positioning



Fund Commentary - November 2023

November was a seasonally strong month for equity markets. Market breadth returned to the market as bond yields declined meaningfully due to better than expected inflation data. Global equity markets posted stellar returns during November with the MSCI World index up 9.4% for the month. Much of the growth was driven by both US and European markets which increased 9.4% and 9.6% respectively in USD terms.

When looking at global sectors, technology and consumer discretionary stocks led the way up 15.1% and 20.5% respectively. Consumer staples and energy stocks struggled, with the latter being weighed on by the declining oil price throughout the month. Easing tensions in Ukraine and Palestine coupled with increased fears of a longer period of hawkish monetary policy providing downward pricing pressure on the oil price.

The dollar weakened notably versus Sterling and the Euro, reversing the appreciative trend we have been seeing since mid July. Over the course of the month, the Dollar depreciated -2.7% with the Euro and Sterling gaining 2.8% and 3.5% respectively.

The US FED held rates at 5.5%, as expected by the market, marking the second consecutive pause since June this year, with the market largely expecting no action in December. There isn't any logical reason to keep raising rates at this present time due to the labor market remaining relatively tight and stable and inflation coming in below estimates during the last release.

Core inflation now stands at 4% with headline down to 3.2%, nearing, but not yet close enough to the elusive 2% target. Throughout November the best performing sectors within the fund were consumer discretionary +20.5%, utilities +15.5% and technology +15.1%. The detractors were energy -2.8% and consumer staples +3.4%.

On an individual stock basis, the best performing were Monolithic Power Systems +24.2%, UBS +21.4% and Amadeus +20.5% with the detractors being Schlumberger -6.5%, Exxon -2.1% and BP +1%. The fund finished the month up 8.9% versus the benchmark return of 9.4%.

The Scheme is an open-ended investment company, which was registered with limited liability in Guernsey on 20 May 2010, and is authorised by the Guernsey Financial Services Commission ("GFSC") as a Class B Collective Investment Scheme. The Scheme is an umbrella company constituted as a Protected Cell Company under the Guernsey Companies Law. The provisions of the Companies Law enable a company to which it applies to create one or more cells for the purpose of segregating and protecting the assets within those cells so that, on the basis that the company complies with the conditions laid down by the Companies Law, liabilities of the company attributable to one cell can only be satisfied out of the assets of that cell and even if those assets are insufficient, recourse cannot be had to the assets of any other cell.

Guernsey International Management Company Limited is the registered Manager of the Scheme and the Fund, and is approved to provide investment management services to collective investment schemes in Guernsey by the GFSC. The Manager does not provide any guarantee, either with respect to the capital or the return of this cell. Martello Asset Management Limited (the "Investment Advisor") (Company Registration No: 127947) is responsible for managing the assets of the Fund. The Fund complies and is managed within the investment restrictions and guidelines for Foreign Collective Investment Schemes in terms of the Act. The Scheme and Fund are approved in terms of the Act. The Fund may use derivatives for efficient portfolio management purposes only, which may include currency hedging. Short-term borrowing will be allowed to the amount of 10% of the value of the Fund, only for purposes of the redemption of participating shares. The cell is valued daily at 23h00, on the business day preceding dealing day and is traded at the ruling
