#### **Investment Objective**

The Martello Global Equity Fund ("the Fund") aims to achieve long term capital appreciation through investment in listed equities on a global basis.

The fund is primarily intended for investors with a long-term horizon of at least 5 years.


#### Investment Strategy

The Fund will invest in a diversified portfolio of listed equities. Assets of the Fund are typically limited to, but not confined to, those companies listed on the markets of the UK, Europe and North America.

The investment advisor will apply a rigorous investment selection methodology to select securities for the Fund's investment portfolio. These criteria are designed to ensure that the Fund invests in high quality businesses with proven management competencies and strategy execution.


It is envisaged that the investment portfolio of the Fund will be concentrated, comprising between 20 and 30 stocks. However, the portfolio will be invested with the aim of providing a prudent spread of risk, and there are limits on the concentration of the investments held.






## Fund Commentary - March 2024

March was a very strong month for equity markets. The same trends that had been influencing markets in the first 2 months of the year, continued throughout March. We saw a broadening of sector participation, coupled with some of the previously lagging sectors perform exceptionally well. The fund returned 2.9% during March versus the 3.2% return of the benchmark.

From a market perspective, the main equity indices continue to trend higher. Upside market participation is broadening while credit spreads remain tight. Cyclicals vs. defensives are exceeding expectations, whilst the recent pick-up in commodities and outperformance of TIPS over US Treasuries point towards a "reflationary" message. The best performing sector in March was not tech – in fact, energy, industrials and financials all produced better returns as the overheated tech sector traded sideways in March, and the dispersion of returns within the tech heavyweights widened considerably.

Contribution to performance was shared across both the US and European equity lists during the month, with a broad range of sectors also involved. We see this as a positive outcome, as the concentration risk of a narrow segment of the market is replaced with a wider focus on earnings growth and valuation across more sectors and regions.

During March we increased our energy exposure, topping up Exxon and Schlumberger, both of which have performed well both YTD and during March.

Throughout March the best performing sectors for the fund were energy (+12.3%), industrials (+7.3%) and consumer discretionary (+6.0%). The lagging sectors for the month were staples (-0.5%) and technology (-0.1%). On an individual stock basis, the best performing were Rolls Royce (+15.5%), Schlumberger (+13.4%) and Airbus (+11.4%). The laggards for the month were Alimentation Couche-Tard (-14.7%) and Monolithic Power Systems (-7.8%).

The Fund was approved by the Financial Sector Conduct Authority of South Africa on 30 July 2020 in terms of Section 65 of the Collective Investment Schemes Control Act, 2002 (the "Act"), Notice 2076 of 2003 as amended by notice 1502 of 2005 ("the conditions"). The Fund complies and is managed within the investment restrictions and guidelines for Foreign Collective Investment Schemes in terms of the Act. The Scheme and Fund are approved in terms of the Act. Short-term borrowing will be allowed to the amount of 10% of the value of the Fund, only for purposes of the redemption of participating shares.
