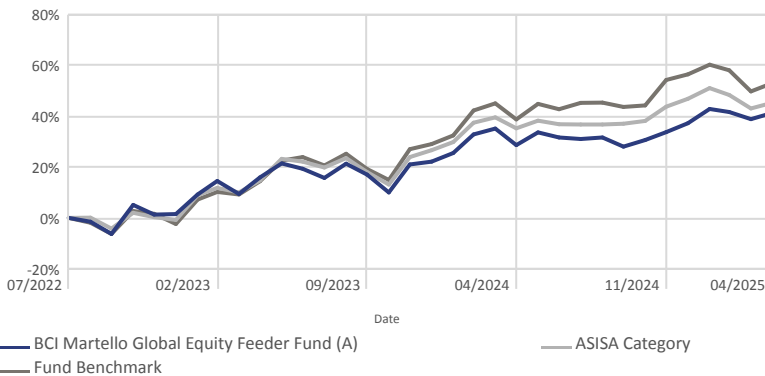
INVESTMENT OBJECTIVE

The objective is to provide investors with a long-term capital growth.

INVESTMENT POLICY

The BCI Martello Global Equity Feeder Fund aims to provide investors with a long-term capital growth. The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the Martello Global Equity Fund, a cell of The Offshore Mutual Fund PCC Limited, domiciled in Guernsey. The underlying portfolio mainly invests in a diversified range of typically 20 to 30 global developed market listed equities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

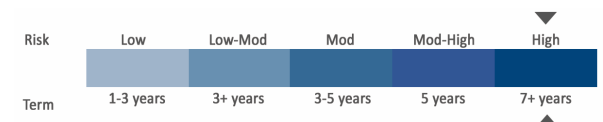

- Therefore, it is suitable for long term investment horizons.

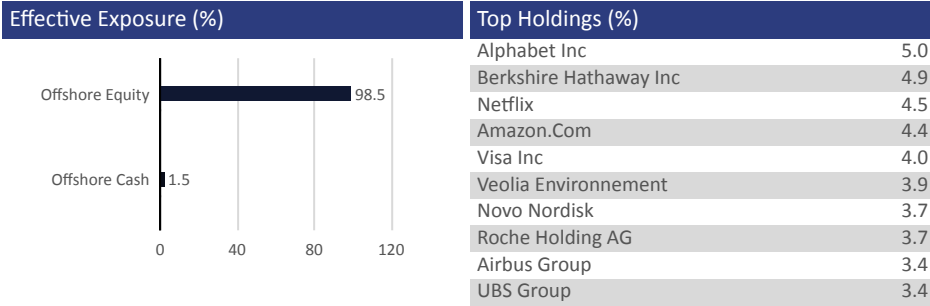
